**HOW TO PREPARE:** Shake contents well before using. Mix 333mL with 9 litres of water. Apply over 33 square metres.

**HOW TO APPLY:** Apply be means of watering can with a sprinkle bar attachment or coarse garden sprayer. Spray directly on weeds until foliage is guite wet. Wash out spray equipment thoroughly after use.
